

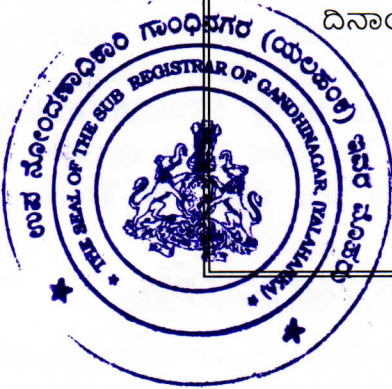

2. The Present Trustees have amended Trust Deed dated: 24-08-2007 as hereunder;

3. OBJECTIVES OF THE TRUST :

- To apply Central or State Government or its undertakings for any agency, dealership, distributionship, for allotment of any Sites, Lands, Civic Amenity sites or such other things.
- To acquire, takeover or merge, amalgamate and run any other educational institutions, schools, collages, training institutes, Trusts & societies.
- To receive donations, grants, subsidies of any kind from any organization, individuals, societies, Trusts, companies, and Central or State Governments or its undertakings.

4. Bank Account Operations, the Bank Accounts shall be operated either by Chairman or Managing Trustee or both jointly.

5. TRUSTEES: APPOINTMENT AND RETIREMENT:

- The Trustees may from time to time by an instrument under their hands appoint additional Trustees or Trustee to fill a vacancy and such trustee or Trustees shall hold for the year or till Resignation or death whichever is earlier.
- A Trustee shall be deemed to have been discharged and his office shall become vacant on the happening of all or any of the following events.
 - If he is found to be of unsound mind by a court / competent authority.
 - If he is adjudicated or if he applies to be so adjudicated as insolvent.
 - Except the founder trustees the trustees shall be deemed to have been discharged and his/her office shall become vacant if the remaining Trustees at a form meeting pass a resolution by majority
